Tuition & Fees:

Tuition and annual registration fees are charged on a yearly basis and are non-refundable. Tuition is divided into ten equal installments for the convenience of our families. Tuition is due on the 10th of each month. A late fee of \$40 will be charged for payments received after the 10th of the month. A \$35 bounced check fee is charged for any bounced checks or rejected ACH. (Initials : _____)

Delinquent Tuition:

First tuition installment is due on August 10th and must be paid before a student can begin attending school. The second installment is due September 10th. If tuition is not paid by the 10th of the month, the account is marked as delinquent and a \$40 non-refundable late fee will be added. If the delinquent tuition payment is not made by the 10th of the following month, another \$40 late fee will be added and the student(s) will be withdrawn from school the following day. If the family pays the delinquent tuition and is re-enrolled again, they will be required to sign up with automatic checking withdrawal to continue the school year. The school reserves the right to hold academic records until all financial commitments are paid in full. (Initials : _____)

Financial Aid Awards:

Financial Aid is awarded to families who are unable to pay full tuition. Families must apply each school year by the deadline and must meet income qualifications. Awards are issued on a first come, first serve basis. Financial Aid Awards are determined by the Financial Aid Committee. Financial Aid is awarded from available funds that include zakat, sadaqah, and general donations. Families are notified of the award amounts in writing. By accepting the financial aid award, you agree and authorize Nur Islamic School of Louisville to collect zakat, sadaqah, and general donations on your behalf. (Initials : _____)
