TUITION PAYMENTS POLICY:

- Families can choose to pay annual tuition in one full payment via check or bank account/ACH withdrawal.
- Families paying in ten (10) equal installments must sign up for automatic bank account/ACH withdrawals. Tuition in ten (10) equal installments (monthly) will be debited between the 10th and the 15th of each month, from August to May. A failed transaction fee of \$40 is added to the month in case of failed ACH payment. If tuition is not received by the 15th of the month, a late tuition fee of \$40 is added to be collected via ACH withdrawal.
- **Two failed ACH payments will result in being put on financial probationary status. The third failed ACH payment will result in the family being unenrolled effectively immediately after the current month's tuition fails and the student(s) will not be able to attend classes until all financial balances are paid in full. NISL also reserves the right to request bulk quarterly cash payments for tuition after two failed ACH payments.**
- **Lunch fees must be prepaid at the beginning of each month or will be taken by automatic bank withdrawal monthly.**
- Sibling discounts are applied on the second and additional child after the oldest.
- Report cards, transcripts, and test results will not be released if the tuition and any other outstanding fees are not paid in full.
- Families taking a leave of absence from school for travel purposes are still liable for the full tuition payments.
- Transferring students who transfer after the second month of school will have their tuition prorated. The annual registration fee is nonrefundable, due in full, and will not be prorated, regardless of when the student transfers.
- Families who cannot afford full tuition may apply for tuition discounts through FACTS by going to <https://online.factsmgmt.com/signin/4KXLN>. The School code is 36387. Tuition discounts are awarded only to eligible families on a first-come, first-serve basis, until the tuition assistance funds run out.

THE TUITION AMOUNTS LISTED ABOVE DO NOT INCLUDE COSTS ASSOCIATED WITH THE FOLLOWING ITEMS:

All additional fees listed above and any other applicable school-related costs are billed as incurred and at the rates determined at the time of service. These fees may vary from year to year based on vendor pricing, program costs, and operational needs.
